
### **OUR MISSION STATEMENT:**

# What is Travis County Services for the Deaf and Hard of Hearing?

TCSDHH is an agency that provides social services to adults who are deaf and hard of hearing. TCDSHH also provides communication related services between deaf persons and hearing persons in Travis County agencies and a few other agencies by contract. We can also advocate for legal rights, ADA access and communication access.

#### Who can use TCSDHH's services?

Any person or Travis County agency may request communication assistance, case management services, counseling, advocacy services and information and referral. Community agencies may also contact us for referrals to appropriate community-based resources for services.



## Services for the Deaf & Hard of Hearing provides:

- Case Management
- Crisis Intervention
- Assistance with legal system
- Advocacy
- Information and referral
- Notary Service
- Interpreting services
- Outreach/education to City of Austin & Travis County Departments
- Adaptive equipment for low income deaf persons
- Computer Assisted Real Time Captioning (CARTS) for Travis County functions on request
- Public station for video phone calls



### Interpreters are provided for appointments with:



- Travis County Court and Jail
- Commissioners Court
- Health and Human Services of Travis County including: Family Support Services (emergency assistance), Healthy Families, Weatherization
- Counseling/Programs of Travis County including: The Short Program, Hot Check classes, Violence Diversion, and Substance Abuse & Counseling
- Various Travis County offices including: Constables, Justice of Peace, Sheriff, Tax Assessor, Justice & Public Safety, County Clerk, Community Supervision, & Corrections, etc.
- City of Austin Municipal Court
- City of Austin Health Department, HIV/ AIDS program, CommUnity Care Clinics, Environmental Health Services, Family Health Services, Youth Services, and Immunization



### Legal service coordination includes:

- Educating deaf people about the legal system
- Providing case management for deaf persons in jail
- Educating the legal system about the needs of the deaf people
- Advocating for equal access to jail, court, and legal services
- Providing information and referral to legal agencies
