

How to Create an IRS Account


You will need access to an email address and cell phone (to receive notifications), as well as a valid photo ID.

Common Reasons as to why client's would need an IRS account:

Pull a Transcript
Verify EIP Payments Received
Confirm Balance Due
Make a Payment

Sign In or Create a New Account



IRS now offers a sign-in option with ID.me, which offers access to IRS online services with a secure account that protects your privacy.

ID.me is an account created, maintained, and secured by a technology provider.

If you don't have an ID.me account, you must create a new account.

Sign in with an existing account

Sign in with **ID.me**

OR

Create a new account

ID.me Create an account

You will need to enter your email address and create a password for the account. You will have the option to create an ID.me account using your existing Gmail, Facebook, Apple, or LinkedIn account.

Note: you may have created an ID.me account through a separate government agency ex. Texas Workforce Commission, Social Security Administration, etc., if so, you will need to use that ID.me account to create your IRS account

After clicking ID.me Create an account, use your personal email and enter and confirm a new password. Click I accept the **ID.me Terms of Service and Privacy Policy** And hit the create account button.



CONTINUING TO THE INTERNAL REVENUE SERVICE

To protect your identity and information from fraudulent actors, your authentication and transaction-related data (the information related to your ID.me account and identity verification) will be shared with the IRS. This helps ensure that it is really you interacting with the website and not someone pretending to be you.

This information includes transaction-related data like the following:

- Prior sign-ins using your ID.me account (but the names of the websites you access would not be disclosed)
- Multi-factor authentication methods (e.g., text message or push notification)
- The status of your verification at (e.g., what steps you have or have not completed; partially entered information)

If you choose not to continue, you will not be able to use your ID.me account to access IRS.

ID.me does not sell, lease, or trade data to any third parties or derive any profit from the sale, lease, or trade of data.

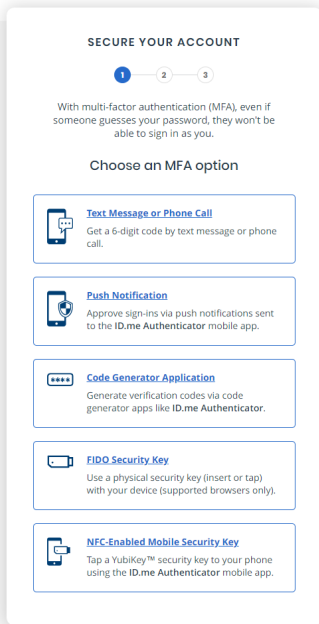

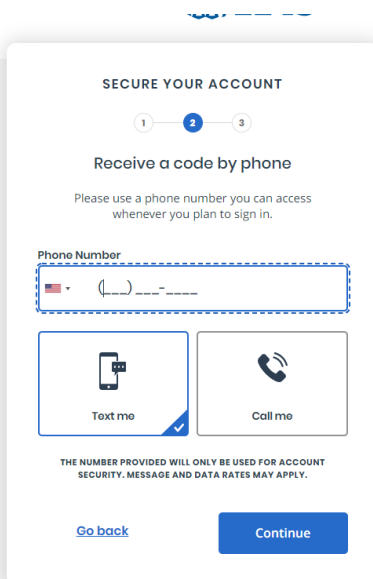
Enter the 6-digit code from the email below.

You will be asked to verify the email that you used when creating your IRS account. To continue with creating your IRS account, ID.me will send you an email containing a six digit code. Enter the six digit code from your email onto the ID.me webpage and click continue.

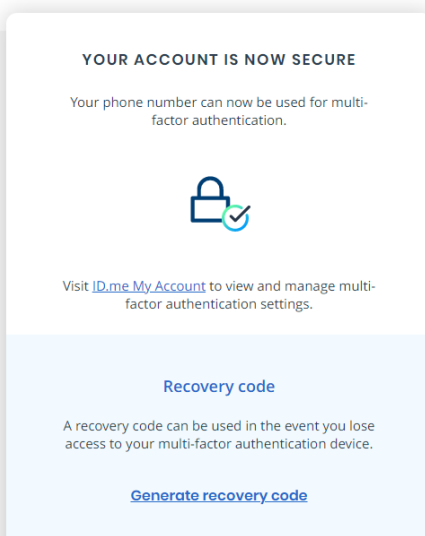


Securing your account

After securing your email, you'll need to complete the multi-factor authentication. Click on Text Message or Phone call and proceed to the next screen



Input your phone number and wait for a text with a six digit code. Input that code to verify your phone number. Move on to next screen



Your account is secure via your mobile phone number. Click continue to move forward with creating your IRS account.

VERIFYING IS FAST AND EASY

Choose how you verify your identity:

- Self-Service (Faster Option)**
- Requires Driver's License / State ID, Passport, or Passport Card and a selfie
 - Selfie and biometric data will be deleted
 - Takes 5 - 10 minutes
- Video Chat Agent**
- Requires [at least 2 identity documents](#) and a 5 - 10 minute recorded video chat
 - No selfie or biometric data collected
 - Video will be deleted
 - Current wait time for next available agent is about 39 minutes
