Mailing Returns & Extensions on Tax Day – April 15th, 2024

All 2023 tax returns or extensions MUST be postmarked or e-filed on or before midnight on April 15th, 2024 to be considered on time.

Taxpayers can visit this IRS.gov webpage to electronically file an extension for free: https://www.irs.gov/filing/free-file-everyone-can-file-an-extension-for-free

No Austin area Post Offices are open late on Tax Day.

Collection Boxes (blue mailboxes) have final pick-up times between 5pm and 6pm in the Austin area. Be sure to verify the hours of operation and final collection time. A stamped envelope must be deposited in a collection box prior to the last scheduled pick up time to receive the April 15th postmark.

Consider using the self-service kiosk at a Post Office. (This requires purchasing postage with a credit or debit card.) The self-service kiosk postmarks the envelope with the date and time and will be accepted as timely filed as long as the postmark is before midnight on April 15th, 2023.

Note: The USPS website indicates the self-services kiosks are open 24 hours per day, but in our experience the kiosks are only accessible during the regular business hours of that location.
